DUES DEDUCTIONS: I authorize MCCC to deduct dues/fees from my pay. → (Send right away so we can meet college payroll deadlines!)

I hereby authorize the treasurer/bursar or the university/college to deduct each year the current dues/fees of my local, county, state and national teachers associations notwithstanding any increases or decreases in such dues/fees in future years. I understand that the specific amount of the current dues/fees of the associations shall be certified to the treasurer/bursar by my local association treasurer each school year. The deductions shall be made in accordance with the agreement between the teachers association and the university/college as it may be amended or renewed from time to time, including any successor agreements and in the absence of any such agreement such deductions shall be made pursuant to C 180 S. 17C as most recently amended. I understand that I must give at least sixty (60) days notice to the treasurer/bursar to withdraw this authorization for a subsequent school year. I further understand that by acceptance of MTA/NEA/MCCC membership, I am obligated to pay the full annual dues for each year as determined by MTA/NEA/MCCC bylaws.
